S.K.KHANNA, MEMBER OF THE SUPERVISORY BOARD, JAYPEE INSTITUTE OF INFORMATION TECHNOLOGY UNIVERSITY, A-10, SECTOR-62, NOIDA-201307.

ITEM NO.1: TO REPORT THE MATTER REGARDING ALLOTMENT OF LAND OF 7 ACRES AT GOVT. POLYTECHNIC, VIJAYAWADA.

The Chairman welcomed the Members and apprised them about the activities of SPA(V) and requested the Director to inform the Members about the allotment of land and Plans to utilize the land in the near future.



The Director informed the Members that the The Government of Andhra Pradesh has allotted 7 acres of Land at ITI Road, next to Govt. Polytechnic, Vijayawada and the possession of land has been taken by the School on 22nd February, 2010.

ITEM NO.2: TO CONSIDER THE PROPOSAL FOR CONSTRUCTION OF TEMPORARY STRUCTURES AND PERMANENT STRUCTURES TOWARDS BUILDING SPA(V) CAMPUS, ITI ROAD (NEXT TO GOVT. POLYTECHNIC), VIJAYAWADA.

The Director apprised the Members that there is a need of urgent temporary accommodation since the ANU has already requested for vacating the Campus by the end of the current academic session 2009-10 i.e. May, 2010, to accommodate the students, teaching and administration and to meet the other essential facilities.

After detailed discussions, the Committee decided as under:-

- (i) The present accommodation at ANU has to be continued for atleast one more year but the existing academic requirement and that of upcoming session may be accommodated at recently acquired land of 7 acres. This may be done by erecting the reusable temporary structures of 2500 sqm.. The estimated cost of the temporary structure including electrical, plumbing and necessary compound wall etc. is Rs.3.5 crores.
- (ii) The possibility of using present accommodation available at ANU to be utilized for hostels so that all the hostels can be placed in one location for better management and the academic activity could be conducted at Polytechnic location.
- (iii) SPA(V) should pursue the proposal of obtaining 3 acres of additional land from Govt. Polytechnic, Vijayawada as early as possible. It was further mentioned that 28 acres of land at Vijayawada would be available soon in near future. The SPA(V) would attempt to prepare a Draft Master Plan for consideration of the Building and Works Committee incorporating all Institute activities including academic etc. at this Campus.



- (iv) For developing 2500 sqm of temporary accommodation following steps be followed:-
 - Design specifications should be prepared.
 - DPMT (Departmental Project Management Team) should be constituted.
 - Prequalification by the DPMT Calling of tenders from prequalified Agencies/ Contractors.
 - Appointing PMC [Project Management Consultant)] (outsourcing) for six months

The meeting ended with a vote of thanks to the Chair.
