As per the norms of Govt. of India Reservation Policy (Annexure III), the reservations of seats in the Admissions for "Kashmiri Migrants" and "Defence Services" under supernumerary seats are proposed for Bachelor's Degree as furnished below for the Academic Year 2021-22 onwards:

The Senate noted the same and approved the proposal for reservation of seats in the Admissions for "Kashmiri Migrants" and "Defense Services" under Supernumerary seats as per Govt. of India

Discussions:

As per the approved minutes of the Third Senate vide Item# 3.9(b), the exit option of degree for students who have completed the third year of Architecture and who have not completed the final year of Architecture, it has been recommended for the award of "Bachelor of Building Science" and the same has been circulated to the BoG members through email dated 07.06.2021, for ratification (Annexure IV). As no comments were received from the members it is deemed to be ratified. Hence it is recommended to Award the degree of Bachelor of Building Science to Mr. Pritam Mohanty (1100100156) who has completed the fourth year of Architecture but have not completed the final year Architecture as per the minimum academic requirements. The above item is place before the Senate for consideration and approval.

Some Senate members expressed that a candidate, who will be awarded with the Bachelor of Building Science can become an Arbitrator, building surveyor, Building services Engineer, Construction Manager, Estimator, Quantity surveyor, Site engineer, CAD Technician, Environmental Engineer etc., Also, several Foreign Universities such as Victoria University of Wellington, Rensselaer Polytechnic Institute, Auburn University, Georgia Tech University etc, offers such degree and the candidate can also pursue postgraduate programme in any of the above-mentioned fields.

It was also suggested to look for the possibility of granting the admission to the student for the Final year B.Arch Course based on multiple entry/exit options proposed in the NEP.

Decision

The Senate approved the award of Bachelor of Building Science to Mr. Pritam Mohanty (1100100156) and to all the students who complete the third year of B. Architecture in future in line with the Degrees awarded at SPA New Delhi if they opt to exit.

	Admissions

In view of the prevailing COVID 19 pandemic and lockdown situations in various states and several representations/requests from the candidates, the applications received after due date i.e. 05/04/2021 has been considered till 20/04/2021(15 days) after seeking concurrence from all Deans and Heads and the approval of the Senate Chairperson.

In line with the objective of NEP Policy 2019, Gol., and importance of multidisciplinary, the eligibility for Ph.D. Programmes at SPAV is revised after deliberations and concurrence from all the Dean and the approval of the Senate Chairperson. The eligibility for the admission to Ph.D. Programme has been revised as below:

"Applicants having a Master Degree in Planning/Architecture/other allied fields in appropriate discipline with a CGPA of 6.5 on a 10-point scale (or equivalent) or 60% marks in case of Open/OBC/EWS candidates in the qualifying degree, whereas in case of SC/ST/PH candidates a CGPA of 6.0 on a 10-point scale (or equivalent) or 55% marks in the qualifying degree are considered".

In view of the above revision, a Corrigendum was also issued (Annexure V) and the above item is submitted for ratification of the Senate.

In view of the observation raised by certain Senate Members, it is clarified that there is no conflict between the qualification mentioned in the Academic ordinances for admission, with the qualification advertised in the original and the corrigendum for the said Ph.D admissions. The courses/disciplines considered under them remained the same.

Nevertheless, as suggested by Senate members, henceforth the Allied fields shall be considered as per the expertise and resources available within the Institute for future Ph.D admissions.

Decision

The Senate noted and ratified the Corrigendum to Admission Notification for Doctoral (Part time & Full time) and PG Programme, Academic Year 2021-22 through Direct Admissions.



Item # 11.4 Selection Criteria for admission to various PG Programmes for the Academic Year 2021-22 through Direct Admissions

It is proposed to forego the interviews for admission to various PG Programmes for the Academic Year 2021-22 in view of the second wave of the Pandemic. After detailed deliberations and with the concurrence from all the Deans and Heads and the subsequent approval of the Senate Chairperson, the following criteria will be adopted and the same has been notified to all the eligible candidates for the PG Programme through Direct Admissions for the A.Y.2021-22.

- 1) Online Entrance Examination,
- 2) Portfolio of the works (Dissertation / Thesis / Project Synopsis)
- 3) GATE Score and
- 4) Statement of Purpose

The above selection criteria for admission to various PG Programmes for the Academic Year 2021-22 through Direct Admissions is submitted for consideration and ratification of the Senate.

The Senate noted and ratified the Selection Criteria for admission to various PG Programmes for the Academic Year 2021-22 through Direct Admissions.

Item # 11.5	Weightage of Marks for PG Direct Admissions 2021-22

In view of the change in the selection criteria, the following weightage of Marks for PG Direct Admissions for the A.Y. 2021-22 is proposed for consideration and ratification of the Senate.

(#) For students in the final year or final semester of the UG Programme, the percentage/CGPA obtained by the applicant till the Pre-final year/Pre-final semester as applicable shall be considered.

The selection criteria for Ph.D. programme for the Academic Year 2021-22 shall be the same as followed for the Academic Year 2020-21. There will be an entrance examination as stage 1 and the eligible candidates from stage 1 are required to appear for the interviews & presentations in stage 2 as per the Academic Ordinances 2019 (for Postgraduate and Doctoral Programme) of SPAV.

Few Senate members expressed their concerns with regards to display of weightages of evaluation in the notification. The selection criteria were duly notified through web notice to the candidates and it was placed on SPAV website for information. Moreover, information on the weightages was provided to the queries received from the candidates in the past.

Decision

After detailed deliberations on the weightage allotted to GATE /CEED marks, the Senate ratified the Weightage of Marks for PG Direct Admissions 2021-22

Consideration for revising the Date of first Registration for defining the									
maximum duration for Ph.D. Programme for candidates admitted in October									
2018									

The candidates provisionally admitted in to Ph.D. Programme in SPAV during the Academic Year 2018 completed the admission formalities in October 2018 and subsequently registered for course work in July 2019 after the allotment of Supervisor(s) with a time gap of 6 months. The Supervisor(s) was/were appointed in June 2019 based on the recommendations of the DPGC and approval of the Senate Chairperson. The members have observed that there was a delay of 6 months during the transition time of academic ordinances and shifting of campus due to which the candidates provisionally admitted in to Ph.D. Programme during the A.Y.2018-19 could able to complete the course work in two semesters i.e., First Semester in A.Y.2019-20 (Odd Semester) and Second Semester in A.Y.2019-20 (Even Semester).

In this regard, the Deans and Heads after detailed deliberations recommended to consider July 2019 as the time of joining or first registration for candidates provisionally admitted in October 2018 for defining the maximum duration for Ph.D. Programme and consider the time from October 2018 to July 2019 as Zero Semester (Annexure VI). Further, the members recommended to adjust/account the fee paid by these candidates in 2018 for the A.Y .2019-20. The item was approved by the Chairperson based on the above recommendations and the item is placed in the Senate for ratification.

The Senate ratified the joining or first registration for candidates provisionally admitted in October 2018 for defining the maximum duration for Ph.D. Programme and the time from October 2018 to July 2019 as Zero Semester.

The Ph.D. Scholar, Ms. K Praveena has completed the course work in Even Semester of the A.Y.2019-20 and secured CGPA of 6.25 as against the minimum requirement of CGPA of 7.0 (Clause 5.9.1 of Academic Ordinances, 2019 pg-29). In this connection, the candidate has made a requisition for a chance to continue her Ph.D. programme considering the hard time of



the pandemic (including the medical illness). In line with the deliberations of SRC, the supervisor has made a submission for one last chance to improve the academic grades to Chairperson, DPGC. DoP. Subsequently, the matter was discussed in DPGC on 24-02-2021 and the members after detailed deliberations, considering this as a special case due to COVID-19 pandemic have recommended extension of one semester to Ms. K Praveena for improving the grades to meet the minimum academic requirements.

Subsequently, the matter was placed in the meeting with the Deans and Heads, and the members recommended for one semester extension to Ms. K Praveena for improving the grades with the condition that both the course work and comprehensive examination has to be completed by the Even Semester of A.Y.2020-21 (July 2021). Further the maximum duration of the programme shall remain 6 years from July 2019. (Annexure VI). The item was approved by the Chairperson Senate based on the above recommendations and the item is placed in the Senate for ratification.

The candidate has registered for the course work in Even Semester of A.Y.2021-22 for improvement of grades and appeared for end semester examination held in June 2021. The results shall be declared in July 2021.

The Senate ratified the decision of the DPGC regarding granting the extension of one semester to Ms. K Praveena for improving the grades to meet the minimum academic requirements and to complete the comprehensive examination.

Items for Reporting

Item # 11.8 Training and Internships

The Department of Planning based on the meetings with students and Faculty board have recommended to consider Online Courses for a minimum duration of 24 Lecture/Tutorial Hours + Reading Hours and Assignments in lieu of the 4-6 weeks' summer internship for the A.Y.2020-21 for UG and PG Programmes in view of the COVID-19 pandemic situation.

The Department of Architecture also recommended Online Courses in lieu of compulsory Summer Internship for respective batches of M.Arch (AC), M.Arch (LA) and M.B.E.M. during Even Semester of A.Y. 2020-2021 in view of the second wave of Covid'19 pandemic. Hence, all the students of UG and PG programme of SPAV who have to complete "Compulsory Summer Internship (6 Weeks)" during the present Even Semester of the A.Y. 2020-21", are recommended to complete online course(s) offered through available E-platforms viz., SWAYAM, NPTEL, MOOC, EdX, Coursera, Harvard Online Learning etc., for a minimum of 24 hours in lieu of the "Compulsory Summer Internship (6 Weeks)", in order to fulfill the requirements of summer internships as per the Academic ordinances of 2019. A student can select courses for fulfilling the criteria with each course of minimum 24 hours ensuring that in total the minimum period of 6 weeks is met with, so as to compensate equivalence in lieu of compulsory summer internship. Multiple courses may be taken up for the same.



Also for Practical Training in Architecture (B.Arch VIII Sem), a few students had taken up extra online courses through available E-platforms viz., SWAYAM, NPTEL, MOOC, EdX, Coursera, Harvard Online Learning etc., in addition to regular office training, to compensate for the shortfall in office training time period.

After detailed deliberations, the recommendations of the Department Heads are placed before the Senate for consideration and ratification.

The Senate noted the Reporting Item on the Online Courses in lieu of Compulsory Summer Internship and approved the same.

Item # 11.9 Online Teaching for the Odd Semester of the A.Y.2021-22

Considering the COVID-19 pandemic, it is proposed to continue the online teaching for the Odd Semester of the Academic Year 2021-22 till the situation becomes normal and based on the guidelines of the MoE/UGC/GoAP, the physical reporting of students to campus will be intimated.

The Senate noted the proposal of online teaching for Odd Semester of A.Y.2021-22 I view of the prevailing pandemic and approved the same.

Item # 11.10 List of Activities undertaken at SPAV

SPAV has successfully conducted the Fifth Convocation of SPA Vijayawada through Virtual mode on 30 January 2021. Three Doctoral Degrees, Eighty Post-Graduate Degrees and Seventy-Six Under-Graduate Degrees were awarded at the Fifth Convocation of School of Planning and Architecture, Vijayawada. Seven Gold Medals and Seven Best Thesis merit certificates were given. The Virtual Convocation was graced by the Chief Guest, Ms. Alpa Sheth, Senior Partner, Vakil Mehta Sheth Consulting Engineers, Managing Director, VMS Consultants Pvt. Ltd., Ar. Ms. Brinda Somaya, Chairperson, BoG, SPAV, Prof.Dr. Minakshi Jain, Chairperson of Senate of SPA Vijayawada, Senate Members, Students, Parents and Invitees. Any other items with the permission of the Chair

i. Consideration of students' medical request for Re-examination for 100% of marks

It is apprised that due to the current pandemic, COVID-19 second wave in India, several students of UG and PG programmes have tested positive and were unable to attend the mid semester examinations and classes, and have applied for reexamination and medical leave.

Considering the present pandemic situation as a special case and after examination of the rule positions of UG & PG Academic Ordinances 2019, the members recommended to conduct special exams (mid-semester and/ final end semester examinations) for those students, who are tested COVID-19 positive for 100 % of the marks (instead of 75% as per the academic ordinances 2019). The same were discussed with Heads and Deans and after deliberation, the same were approved by the Senate Chairperson. The above item is placed before the Senate for ratification.

The Senate considered the students requests for the conduct of special exams for 100% marks and ratified the same.

The meeting ended with a vote of thanks to all present.
