In view of the Order of the Hon'ble High Court for the State of Telangana and the State of Andhra Pradesh dt. 20/12/2018 on W.P.No. 17764 of 2018, all the members of the Senate were requested to convey their decision on petitioner's representation vide circulation email dt. 01.01.2019. In response, a few members in line with the said Order have suggested to discuss the matter with an opportunity of personal hearing of the concerned student in this 5<sup>th</sup> meeting of the Senate. In this regard, the said matter is placed for deliberation, consideration and decision.

As per the directions of the Hon'ble High Court for the State of Telangana and the State of Andhra Pradesh, the Senate provided an opportunity of personal hearing for the concerned student Mr. Sumant Sunil Khobragade. After detailed discussions, the Senate granted one-time opportunity for the said student to complete the rest of the B.Arch degree programme (05 semesters) within the 2.5 years in one attempt only. It was decided unanimously that nevertheless this shall not be taken/ quoted as a precedence in future.

- a) Full Time PhD Admissions for the Academic Year 2018-19: The Advertisement for admission notification for Full Time PhD Programme in the Department of Architecture and Planning was given on 19-12-2018. The last date for receiving filled in applications is 16-01-2019.
- b) The PhD registration of the full time PhD Scholar Shri. Haranarayan Dash (1120300001) is due for cancellation due to lapse of stipulated time period (five year for full-time scholars as per R-8.1 of the applicable PhD rules 2011) for the course completion as per the applicable PhD rules of SPA Vijayawada. It is to report that the Scholar has already been given one year of extension as per the approval of the Senate in its third meeting held on 05<sup>th</sup> December 2017 suggesting that no further extension to be given. Despite the given extension, the said scholar has not been able to complete his course. In view of this, his PhD registration shall be cancelled.
