Proceedings	The Dean Academic apprised all members that in continuation to the directives given by the Secretary, Ministry of Education, Govt. of India in the meeting held on 24.05.2023 at Delhi with Director SPA Vijayawada and in order to align with the National Education Policy 2020 and the vision of SPA Vijayawada two Year Full-time Postgraduate Program titled 'Master of Design (M. Des)' has been proposed by the Department of Architecture through a specially constituted committee. The program is envisaged to impart a strong foundation in design education, leverage multi-disciplinary approach, initiate inter-institutional collaboration and industry-academia interface driven output. The skills imparted through this program shall empower individuals to become job creators rather

Accordingly, the details of the proposed M.Design program in terms of background, purpose, career opportunities, course structure, admission eligibility, fee details was circulated to all Senate Members through email on 22nd July 2023 for their comments and consent. Accordingly, email concurrences have been received between 22/07/2023 and 02/08/2023. Thereafter, on 04th Aug, 2023, the finalized signed Minutes of the Item along with the Annexure than explains the Design Programme and its course structure was circulated, which has been placed as Annexure II to the Agenda Notes of 16 <sup>th</sup> Meeting of Senate.
	With this background, the Dean Academic requested the Head of Dept of Architecture and Prof. Dr. Vijayalaxmi lyer to kindly present an overview of the proposed M.Design program along with its concept and course structure.
Proceedings	Thereafter, the Head of Dept of Architecture and Prof. Dr. Vijayalaxmi Iyer presented to all members an overview of the proposed Masters in Design programme in terms of the focus in each of the four semesters.
	After detailed deliberations, the following were suggested by the members:
	a) In addition to B.Arch students who are eligible, the eligibility of students desirous to apply and get admitted from disciplines other than B.Architecture (5 years) may be re-considered as below –  "Bachelors Degree in Engineering/Planning (4 years) with 1 year experience OR Bachelors Degree in Fine Arts (3 years) with 2 years experience OR Bachelors Degree in Design (3 years) with 2 year experience"
	b) The final semester 'Thesis' may be termed as 'Thesis / Terminal Project' considering the nature of final semester deliverables the students may submit.
Decision	With the above suggestions, the Senate approves and recommends the proposal for initiation of 2 year full time PG program of Master of Design (M. Des) at SPA Vijayawada with respect to the Background Note circulated and the Course Structure circulated (placed as Annexure I to this Minutes), to be initiated preferably from AY 2023-24.
Decision	However, the Senate suggests that detailed syllabus for each subject be developed with five modules and suggested readings similar to other PG programs in SPA Vijayawada and placed for approval subsequently through circulation. The same is recommended to be placed in FC and BoG of SPAV for kind consideration and approval.

Decision	The Senate approves that Clause 5.5 (1) of PG and PhD Academic Ordinance 2019 be amended as: "A student is required to complete successfully all prescribed courses in the scheme and attain a minimum CGPA of 5.0. Therefore, the minimum CGPA for award of M.Plan / MBEM / M.Arch / M.UD degree is 5.0 at SPA Vijayawada"

# Summary of Two Year full-time degree of Master of Design (M. Design) Program at SPA Vijayawada

# 1. Background

## 5. Program Details:

The approach to structuring a Master of Design (M.Des) program can vary among different institutions and countries. However, here is a generalized semester-wise approach that is commonly followed in M.Des programs:

#### First Semester:

 Thesis or Major Project Preparation: In preparation for the final semester, students may start working on their thesis or major project proposal. They may identify a research topic, conduct initial research, and define the scope of their project.

#### Fourth Semester:

- Thesis or Major Project: The final semester often revolves around the completion of a thesis or a major design project. Students dedicate their time to research, design development, prototyping, and presenting their final project. This may involve working closely with faculty advisors and engaging in critiques and reviews.
- Electives or Optional Courses: Some M.Des programs offer elective courses in the final semester, allowing students to choose additional courses related to their interests or to gain supplementary knowledge in specific areas.

#### C. Eligibility Criteria (Qualifying Degree)

- a. Bachelor's Degree in Architecture (05 year programme) of a recognised university or equivalent, OR;
- Bachelor's Degree in Engineering/Planning (04 year programme) with 1 year experience from a recognised university or equivalent, and with valid CEED score, OR;
- c. Bachelor's Degree in Fine Arts (03 year programme) with 2 year experience from a recognised university or equivalent, and with valid CEED score, OR;
- d. Bachelor's Degree Design (03 year programme) with 2 year experience from a recognised university or equivalent, and with valid CEED score.

#### D. Marks/Grades Eligibility

For admission to M.Des programme at SPAV, the candidate must have a CGPA of 6.5 on a 10-point scale (or equivalent) or 60% marks in case of Open/OBC/EWS candidates in Qualifying Degree, whereas in case of SC/ST/PH candidates a CGPA of 6.0 on a 10-Point scale (or equivalent) or 55% marks in Qualifying Degree will be applicable or the applicable GoI norms adopted by the institute from time to time.

#### E. Selection Criteria:

Shortlisted/ Eligible candidates will be notified on the website of SPA Vijayawada and they will be required to appear before the selection committee for admission for interview in person (offline mode only).

- a. Portfolio of Work/ Thesis/ Project (30% weightage)
- b. Statement of Purpose (description of the interest and motivation) (10% weightage)
- c. Interview (60% weightage)

Based on the performance in the interview, performance in the above mentioned criteria, merit list of the selected candidates will be uploaded on the SPA, Vijayawada website.

#### F. Sponsored Candidates:

- a. Sponsored candidates shall be admitted under self-financed category only
- Candidates sponsored by Central Government, State Governments, statutory organizations and public institutions must be in regular service.
- A candidate will be considered as sponsored if the sponsoring organization undertakes to provide him or her with full salary or adequate financial assistance for the full duration of the programme.
- d. Educational qualifications are the same as listed above for each programme, respectively. In addition, a sponsored candidate must also have a minimum of two years 'work experience in a field relevant to programme in which admission is sought.
- e. Minimum percentage of marks may be waived for applicants who are faculty members in academic institutions and have been in regular service.

The curriculum of this program would be of multidisciplinary inter-institutional and collaborative in nature, so as to bridge skills of various program fields to achieve synergy and to meet the demands which are sensitive to the regional context and societal needs.

# **SPAV Merit Scholarship**

### A. Background

To encourage the meritorious students, and to inculcate a zeal to excel in academics, to push the highest standards of academic brilliance and to evolve a sense of positive competitiveness in the campus, it is proposed to assist and reward the most meritorious top three ranked students of every batch, with an *SPAV Merit Scholarship*. While such scholarships are often found in foreign universities and IITs, it shall be one of its kinds amongst the SPAs.

# **B.** Conditions of the Scholarship

The SPAV Merit Scholarship is proposed to be rewarded to the following eligible candidates:

- Students who have taken admissions in SPAV through one of SPAV's admission
  procedures at PG or UG level and who have completed at least one year of studies in
  their respective programmes.
- 2. Students who are holding the <u>highest</u> Cumulative Grade Point Average (CGPA) score after completion of (i) 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup>, and 4<sup>th</sup> academic year in B.Arch; (ii) 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup> academic year in B.Plan; (iii) 1<sup>st</sup> academic year in M.Arch / M.BEM / M.UD / other PG programmes if any; (iv) 1<sup>st</sup> academic year in M.Plan, and are to be declared as "1st Rank Merit Scholar".
- 3. Students who are holding second highest Cumulative Grade Point Average (CGPA) score after completion of (i) 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup>, and 4<sup>th</sup> academic year in B.Arch; (ii) 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> academic year in B.Plan; (iii) 1<sup>st</sup> academic year in M.Arch / M.BEM / M.UD / other PG programmes if any; (iv) 1<sup>st</sup> academic year in M.Plan and are to be declared as "2nd Rank Merit Scholar".
- 4. Students who are holding third highest Cumulative Grade Point Average (CGPA) score after completion of (i) 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup>, and 4<sup>th</sup> academic year in B.Arch; (ii) 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup> academic year in B.Plan; (iii) 1<sup>st</sup> academic year in M.Arch / M.BEM / M.UD / other PG programmes if any; (iv) 1<sup>st</sup> academic year in M.Plan and are to be declared as "3rd Rank Merit Scholar".

- 5. The student should not have any subject cleared in more than one attempt in any years of studies, preceding year of scholarship.
- 6. The candidates should not have any unfair means cases in their tenure as students of SPAV.

# C. Quantum of Scholarship

The quantum of merit scholarship shall be as below:

- a) For the 1<sup>st</sup> Rank Merit Scholarship, the students shall be awarded in the form of a tuition fee waiver of 40% of Annual Tuition Fees of the forthcoming Academic Year. For the 2<sup>nd</sup> Rank Merit Scholarship, the students shall be awarded in the form of a tuition fee waiver of 35% of Annual Tuition Fees of the forthcoming Academic Year. For the 3<sup>rd</sup> Rank Merit Scholarship, the students shall be awarded in the form of a tuition fee waiver of 25% of Annual Tuition Fees of the forthcoming Academic Year.
  - For example, the highest CGPA holding student or the 1<sup>st</sup> Rank Merit Scholarship of 2<sup>nd</sup> Year of B.Arch on being awarded the scholarship will have to pay 60% of the annual tuition fee of the forthcoming 3<sup>rd</sup> Year Academic Year (with a waiver of 40% fee). The student awarded 2<sup>nd</sup> Rank Merit Scholarship for 2<sup>nd</sup> Year of B.Arch will have to pay 65% of the annual tuition fee of the forthcoming 3<sup>rd</sup> Year Academic Year (with a waiver of 35% fee). The student awarded 3<sup>rd</sup> Rank Merit Scholarship for 2<sup>nd</sup> Year of B.Arch will have to pay 75% of the annual tuition fee of the forthcoming 3<sup>rd</sup> Year Academic Year (with a waiver of 25% fee).
- b) The list of merit scholars will be declared by the Controller of Examinations after taking due approval of Competent Authority through proper channel.
- c) The merit students shall receive a certificate of appreciation for their academic merit excellence, for this purpose, as prepared by the School.

# **Financial Feasibility**

The financial implication of awarding these scholarships to about 45 toppers (03 rankers X 15 batches, as explained below) are about maximum of **Rs 14,65,000** (if all candidates are GEN/OBC/EWS) and minimum of **Rs 7,36,000** (if all candidates are ST/SC/PWD). This may vary slightly on the exact number of merit scholars in each category.
