Chief Architect for the services rendered in MCD and directed to take further necessary action as per rules.

Prof. Dr. Srikonda Ramesh's matter related to pension benefits presented by Prof. Dr. V K Paul, Member of BoG, the then Chairperson for earlier BoGs, in detail covering his joining through proper channel, his relieving orders from MCD showing to protection of pay, carry forward of the leave account and counting of past service for pensionary benefits, etc., Further MCD has communicated the applicability of OPS after taking the direction from DoP& PW, which is mentioned below:

- 1. Since SPA is under the jurisdiction of Ministry of Education where CCS (pension) Rule, 1972 is followed for the employee appointed before 01.01.2004. Accordingly SPA Vijayawada should also be covered under CCS (pension) Rule. As per DOP & PW clarification, the counting of past services would be available in case new organization is covered under CCS (pension) Rule. Accordingly SPA Vijayawada is covered under CCS (Pension Rule) and is requested to reconsider the Board of Director's decision to grant pension to Sh. S. Ramesh.
- 2. Sh. S. Ramesh has joined new organization i.e. SPA Vijayawada after technical resignation from MCD which in turn means counting of benefits of previous organization. In these circumstances, the new organization i.e. SPA Vijayawada should not had allowed him to opt for NPS. The incumbent shall only be governed under CCS Pension rule.

Thereafter, deliberated that the representation of Prof. Dr.S.Ramesh sent to Ministry (MoE) through Proper channel indicating the following para 5 of the DoP&PW's OM dated 11.06.2020 and requested the applicability of OPS.

)

"those employees who joined Central Government / Central Autonomous body under NPS during 1.1.2004 to 28.10.2009 after submitting technical resignation from Central Govt. / Central Autonomous Body or a State Government / State Autonomous Body and who fulfill the conditions for counting of past service in terms of this Department's O.M. dated 28.10.2009, may be given an option for induction in old pension scheme and to get their past service rendered in the Central / State Government or Central / State Autonomous Body counted for the purpose of pensionary benefits on their final retirement from the Central Government / Central Autonomous Body."

After detailed deliberations, the Board recommended the case of Decision Prof.Dr.S.Ramesh under Old Pension Scheme (OPS) as proposed by MCD referring DoP&PW clarification and send the recommendation of the Board to the MoE for Approval.

The meeting ended with vote of thanks to the Chair.
