Those students who are away from the campus for any reason (including Practical Training) are advised to stay at their respective homes/places, instead of returning to the campus. All sports facilities, cultural facilities, library, laboratories will remain closed for the students during the above period.

All are requested to note that all decisions will be displayed in the official web-site of the Institute only and the Institute does not take responsibility for information from any other source.

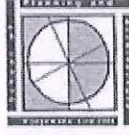
