NOTICE - ELIGIBILITY LIST FOR PhD ADMISSIONS 2023-24

- 1. The applicants, as indicated in Annexure I to III, are eligible to appear for the Qualifying Entrance Examination (Stage I) related to the PhD Admission Process for Doctoral Programmes at SPA Vijayawada. Candidates, who qualify in Stage I, shall be allowed to appear for Stage II (Interview).
- 2. All 'eligible' and 'provisionally eligible' applicants as indicated in Annexure I to III are required to report to the SPA Vijayawada campus by 08.30 AM on 14th June, 2023.
- 3. All 'eligible' and 'provisionally eligible' applicants are required to carry with them, all supporting originals documents (and one self-attested copies of the originals) related to their application in terms of educational background, marks for each semester, degree certificates, provisional degree certificates, valid caste, and category certificates as per Central Govt format, identity proofs, date of birth, NOC as per advertisement requirements, portfolio, etc, as per requirements of the application and advertisement.
- 4. Applicants indicated as 'provisionally eligible' require to produce necessary original documents and their copies as indicated in Annexure I to III, and get their applications verified between anytime 11:00 AM 01:30PM. Interviews in Stage II of admission process for such candidates will be started only upon clearance by verification committee, after verification is done.
- 5. Qualifying Entrance Examination (Stage I) will be held between 09.30 AM and 01.15 PM separately. There shall be three exams of 1 hr duration each, i.e., (a) one exam for PhD in Architecture aspirants (b) one exam for PhD in Planning aspirants and (c) one exam for PhD in Building Engineering and Management aspirants. - 6. Results of the Qualifying Entrance Examination (Stage I) shall be announced on 14th June, 2023 between 02.30PM-04.00PM. Eligible candidates shall then proceed for Stage II (individual personal interviews, assessment of research proposal (write up) and brief presentation of research interest) from 04.00PM onwards till 07.00PM. Stage II may continue to 15th June (starting at 09.30AM), depending on the number of eligible applicants. Applicants are advised to come prepared to be present in campus till end of 15th June, 2023 to complete the Stage II.
- 7. SPA Vijayawada does not provide any boarding or lodging or travel arrangements.
