NOTICE: Admission to Post Graduate Programmes for the Academic Year 2023-24 through Direct Admissions

School of Planning and Architecture, Vijayawada (SPAV), an Institute of National Importance established by the Ministry of Education (MoE) Government of India, announces the Direct Admissions for the Post Graduate Programmes under various specializations of Architecture and Planning for the Academic Year 2023-24.

Postgraduate Programmes at SPAV:

Applications are invited for the Direct Admissions seats for the following programmes of Architecture and Planning.

Total Seats - 25 per PG programme (Two Years Full Time)

Wherein under CCMT– 13 Seats; Wherein under Direct Admissions– 12 Seats (Institute follows seat reservation policy as per Govt of India norms. Seats include Sponsored Category)

A. Department of Architecture

- (a) Master of Architecture (Sustainable Architecture)
- (b) Master of Architecture (Landscape Architecture)
- (c) Master of Architecture (Architectural Conservation)
- (d) Master of Building Engineering and Management
- (e) Master of Urban Design

Eligibility:

- (a) **Sustainable Architecture:** Bachelor's Degree in Architecture from a recognized university.
- (b) Landscape Architecture: Bachelor's Degree in Architecture from a recognized university.
- (c) Architectural Conservation: Bachelor's Degree in Architecture from a recognized university.
- (d) Master of Building Engineering and Management: Bachelor's Degree in Architecture or B.E or B.Tech (Civil Engineering / Building & Construction Technology / Construction Engineering & Management / Construction Technology & Management) from a recognized university.
- (e) Master of Urban Design: Bachelor's Degree in Architecture from a recognized university.

B. Department of Planning

- (a) Master of Planning (Environmental Planning and Management)
- (b) Master of Planning (Urban and Regional Planning)
- (c) Master of Planning (Transport Planning)

Eligibility:

(a) Environmental Planning and Management: Bachelor's Degree in Planning / Architecture or B.E (Civil Engineering) or B.Tech Civil Engineering / Planning or Master's Degree in Geography / Economics / Sociology from a recognized university.

- (b) Urban and Regional Planning: Bachelor's Degree in Planning / Architecture or B.E (Civil Engineering) or B.Tech Civil Engineering / Planning or Master's Degree in Geography / Economics / Sociology from a recognized university.
- (c) Transport Planning: Bachelor's Degree in Planning / Architecture or B.E or B.Tech Civil Engineering / Planning or Master's Degree in Economics / Statistics / Operations Research from a recognized university.

C. Marks/Grades Eligibility:

For all the above PG programmes, the candidate must have a CGPA of 6.5 on a 10-point scale (or equivalent) or 60% marks in case of Open/OBC/EWS candidates in qualifying degree, whereas in case of SC/ST/PH candidates a CGPA of 6.0 on a 10-Point scale (or equivalent) or 55% marks in qualifying degree will be applicable or the applicable Gol norms adopted by the institute from time to time.

D. Admission Process:

Admission shall be made through the following stages:

Stage-I: A Qualifying Entrance Examination will be conducted for the applicants. For more details about the Qualifying Entrance Examination, visit the Admission Section of SPA Vijayawada website.

Stage-II: The candidates clearing the Qualifying Entrance Examination shall appear for the interview. The final merit list shall be prepared based on the marks obtained in the Stage-II, which comprises of Interview and assessment of Statement of Purpose and Portfolio, as per institute norms.

(i) How to Apply:

An applicant can apply for any number of PG programmes offered as given in 'A' and 'B'. However, applicant needs to submit separate application forms and supporting documents as separate sets for each programme applied for. Fee should be paid separately for each PG programme applied for and the fee details to be enclosed in the respective application forms separately. The application form is available on SPAV Website

https://www.spav.ac.in under Admissions section, which needs to be downloaded, duly filled, signed and sent with self-attested copies of required supporting documents. The duly filled in application form received through post, along with the marks sheets of 10th Standard, 12th Standard, UG Degree of qualifying examination, PG degree of qualifying exams, UG and PG semester mark sheets, Birth & Caste Certificate, Online Fee Receipt, and other documents as mentioned in the application form should be sent to SPA Vijayawada by post/courier by the deadline mentioned in 'D(iii)'.

(ii) Students pursuing UG / PG degrees:

The candidates pursuing final year of the UG & PG Programme as per eligibility given in 'A' and 'B', can also apply and must submit the CGPA/Percentage marks secured till the VI Semester (for 4 Years UG Programme) / VIII Semester (for 5 Year UG Programme) / II Semester (for 2 year PG Programme) and submit all marksheets till the said semester. Such a student is required to submit an undertaking/certificate issued by their institute, certifying that the applicant is 'appearing in final examination of final semester'. Such candidates, if provisionally admitted, are required to submit final year mark sheets and provisional degree certificate, prior to the commencement of classes at SPA Vijayawada. Candidates who have completed the eligible programmes are required to produce provisional degree certificates, in case the original degree certificates are not yet issued.

(iii) Deadline and Address to Post:

Application envelopes/packets containing duly filled application form and supporting self-attested documents need to reach the following address on or before **April 10, 2023 05.00 PM**:

Envelopes to be super-scribed with the text "*Application for Admission to (write the name of programme applied for)*" duly mentioning the candidate name with full postal address on the envelope, which to reach the institute through post/ courier/ in person on or before **April 10, 2023 by 05.00 PM**. Applications received after the last date will not be considered irrespective of postal or any other delays. The short listed / eligible candidates shall be notified on the School's website and must produce the original certificates & a set of selfattested photocopies and project work/portfolio etc., at the time of Qualifying Examination/Interview.

E. General Instructions:

(i) Application Fee for PG Programme:

Application fee (non-refundable) for PG programme per course is Rs.2,000/- for General/OBC/EWS categories and Rs.1,000/- for SC/ST/PH categories and can be paid through online only. If an applicant is applying to multiple PG

Programmes, he/she should pay separate for each application & enclose the proof of payment along with each application.

(ii) <u>Reservation of Seats:</u>

Reservations for all the courses will be applicable for SC/ST/OBC/EWS/PH as per rules of the Government of India.

(iii) <u>Guidelines for Sponsored Category:</u>

The candidates who are employees of a Public Sector Undertaking, a Government Department, a Research & Development organization/lab, a recognized Planning / Architectural Office of repute, can apply under the Sponsored category as per norms of the Academic Ordinances. Such a candidate must have been in employment with the sponsoring organization for at least two years at the time of admission and should submit (a) letter conforming sponsorship and study leave (or extraordinary leave) from the organization for duration of PG studies at SPA Vijayawada, indicating period of employment and (b) a No Objection Certificate.

(iv) <u>Submission:</u>

Application forms which are incomplete, not signed, or does not have enclosed the required self-attested copies of documents as indicated in this notification or the application form, is liable to be summarily rejected. On qualifying Stage I the applicant needs to appear for Stage II. The School reserves the right to reject/cancel any application without assigning any reasons.
