Authorization to Director, SPAV to submit the Financial Statements for F.Y 2022-23 to C&AG for taking up Financial Audit. (SAR)
The FC directed to place the Annual Accounts and Financial Statements of the Institute for the FY 2022-23 to FC for its approval and after the approval the same may be submitted to C&AG.
The item may be treated as dropped as the approval to be sought from FC before submitting C&AG.
Approval for the Budget Estimates for the F.Y 2023-24
The FC was appraised that the Budget Estimate for the F.Y 2023-24 was prepared based on the inputs received from various departments. The budget proposed for the F.Y 2023-24 is with a 5% increase of the budget proposed for the previous year.
The FC accorded approval for the Budget Estimates for the F.Y 2023-24 to the tune of Rs.48.00Crores.
Utilization of Funds recovered by CPWD from M/s.Sri Krishna Shelters Private Ltd.
The FC was appraised that SPA, Vijayawada has entrusted the work of development and construction of SPAV campus and buildings to CPWD and deposited an amount of Rs.139.79Cr.  CPWD informed that the work of construction of SPAV Campus was awarded to the agency, M/s.Sri Krishna Shelters Private Limited during August 2014. As the agency was not executing the work with due diligence, the contract was determined and the compensation of Rs.10.44Cr. was levied. The same was included in the advance paid to CPWD by SPAV, out of which, CPWD has incurred an expenditure of Rs.9.68Cr. and the balance available is Rs.0.76Cr.

	Further, CPWD informed that if any amount is liable to pay to M/s.Krishna Shelters Pvt. Ltd., due to any judicial process in future, that SPAV shall have to provide the required fund at that time as the agency has filed an appeal in the Hon'ble Supreme Court.
	CPWD has completed the construction and development of SPAV Campus buildings during the year 2018 and the building has been capitalized.
	In this context, the SPAV proposed to create a committed liability, till the final verdict is pronounced by the Hon'ble Court, it is proposed to sanction an amount of Rs.10.44Cr. under OH-35: Capital by the MoE, Govt. of India. may be invested in Fixed Deposits and paid to CPWD if required and the interest earned on Fixed Deposit may be returned to Govt. of India Account.
Decision	After detailed discussion and deliberation, the FC directed to send a detailed proposal to the MoE for examining the proposal.
22.04	Up-gradation of pay of Sh.S.V.Krishna Kumar, Associate Professor.
Discussion	The Board was informed that the pay of Sh.S.V.Krishna Kumar needs to be upgraded in accordance with the instructions issued by the erstwhile MHRD vide letter dt.26.08.2010 and fixed in Pay Band:3 Gr.Pay Rs.9,000/- w.e.f.14.12.2012 and he may be paid arrears. It was also informed that the similar cases were granted upgradation in SPA Bhopal.
Decision	The Board accorded approval for up-gradation of pay of Sh.S.V.Krishna Kumar as per Rules and in accordance with the instructions issued by MHRD.
