Item # 14.3	Revision of Eligibility Criteria for Admissions to PhD Programmes in SPA Vijayawada	
Proceedings	The Dean Academics apprised all members, that an Inter-departmental Committee was constituted to look into the aspects of Eligibility Criteria for Admissions to PhD Programmes in SPA Vijayawada and presented the proposed criteria for Eligibility Criteria as circulated in the Agenda Notes of this Meeting. The proposed criterion is aimed to increase admissions to PhD and enhance the research milieu of SPA Vijayawada. The Senate discussed and deliberated on the phrase 'with appropriate specialization' may be considered to be applicable to Master in Architecture and Planning. The members also suggested to look into possibilities of admitting candidates with PG degree of other disciplines, in the future.

The proposed maximum number of supervisions was presented. After detailed discussions, the Senate concludes as below:

Proceedings	of studies are about to finish as per the course structure and syllabus for the first semester which was placed in the Agenda Notes of 13th Meeting of the Senate. In this regard, HoD Architecture presented the detailed syllabus and course structure of MUD Programme for all the semesters as circulated with the Agenda Notes of this Meeting. The Senate deliberated in detail and the suggested that the subjects for each semester is to be detailed into sub-units with suggested reading references. After detailed discussions, the Senate appreciated the efforts for the development of the syllabus and the programme and concludes as below.

Item # 14.10	Any Other Item with the permission of the Chair
(A)	Approval of Academic Calendar for All batches for till end of A.Y 2022-2023
Proceedings	With the permission of the Chairperson, the Dean Academic together with the HODs apprised the members that presently there had been three Academic Calendars in execution till December 2022, due to different times of joining of the UG and PG batches through JoSAA and CCMT and DASA (admissions conducted by the Ministry of Education, Government of India). The three calendars are – (a) Calendar for UG 1st Years; (b) Calendar for UG 2nd Years and PG 1st Years; (c) Calendar for UG 3rd, 4th and 5th years & PG 2nd Years. This staggered calendar has been leading to difficult overlaps of timetables, fieldworks, exams, supplementary, and vacations. In order to streamline all the calendars, so that all batches finish the academic year in similar time in the upcoming semester, a combined syncronised academic calendar has been prepared where the semesters for the A.Y. 2022-23 has been condensed for I Year UG Programmes due to delayed admission (admitted in mid Nov 2022). The HoDs have been given permission to conduct extra hours of classes in weekdays and weekends as per teaching requirements to compensate the condensed academic calendars. The two academic calendars were presented/tabled to all members (enclosed as Annexure II to this Minutes). After detailed deliberations, the Senate concludes as below:
Decision	The Senate approves the Academic Calendars for all Batches till the end of Academic Year 2022-23, as presented, for its implementation.
(B)	Approval for the Award of Bachelor of Building Science to Mr. T. Sri Ram having Reg no. 1190100881 in upcoming Convocation.
Proceedings	The members were apprised that Mr. T. Sri Ram having Reg no. 1190100881 requested for withdrawal from B.Arch programme after completing the 3 years of B.Arch degree. His withdrawal was approved by the Department and his refunds are under process. He has requested for awarding of certificate on 03-08-2022 for his period of study at SPA Vijayawada. In this regard, as per the Ordinances of undergraduate programmes of SPAV, the Department of Architecture have conducted DUGC meeting on 13-12-2022 and recommended for awarding of "Bachelor of Building Science" degree, after looking into the credits earned for his completed 3 years of studies. This is in line with the decision of 3rd Senate Minutes dated 05-12-2017 regarding Exit Option by Degree. viz., 'Bachelor of Building Science' for the candidates of B.Arch who are not able to complete the degree through 5 years of study but have earned all credits for the first three years of study. This is also in line with the decision of Senate in its 11th Meeting Minutes dated 09-07-2021, where Mr. Pritam Mohanty (1100100156) was decided to be eligible to receive 'Bachelor of Building Science' degree as per the item # 11.2 of 11th Senate meeting on 09-07-2021, further ratified by BoG of SPA Vijaywada. After detailed deliberations, the Senate appreciated the efforts and concludes as below.
