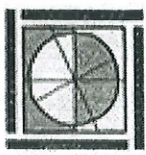


NOTICE – ELIGIBILITY LIST FOR PG DIRECT ADMISSIONS 2024-25

1. All 'eligible' and 'provisionally eligible' applicants as indicated in Annexure I to IX herewith are required to report to the SPA Vijayawada campus by 08.00 AM on 25th April 2024 and thereafter appear for the Qualifying Written Entrance Examination (Stage I) related to the Direct Admission Process for PG programmes at SPA Vijayawada.
2. Applicants indicated as 'provisionally eligible' are required to produce necessary original documents and their copies as indicated in Annexure I to IX and as per S.No 3 below, and get their applications verified between 08.00AM – 08.45AM and between 10.30AM – 02.15PM on 25th April 2024. *Interviews in Stage II of admission process for such 'provisionally eligible' candidates will be started only upon clearance, after verification is done and upon qualifying in the Qualifying Written Entrance Examination (Stage I).*
3. All 'eligible' and 'provisionally eligible' applicants are required to carry with them, all supporting originals documents (and one self-attested copies of the originals) related to their application in terms of educational background, marks for each semester, degree certificates, provisional degree certificates, valid caste and category certificates as per Central Govt format, identity proofs, date of birth, NOC, portfolio, etc as per requirements of the application and advertisement.
4. Qualifying Entrance Examination (Stage I) will be held between 09.00 AM and 02.00 PM separately. There shall be four exams of 1 hr duration each, i.e., – (a) one exam for all M.Arch (MSA, MLA, MAC) and MUD aspirants, (b) one exam for all M.Plan (MEPM, MURP, MTP) aspirants, (c) one exam for MBEM aspirants, and (d) one exam for M.Design aspirants. 5. Results of the Qualifying Written Entrance Examination (Stage I) shall be announced on 25th April 2024 between 02.30PM - 04.00PM. Candidates qualified in Stage I shall proceed for Stage II (individual personal interviews and assessment of portfolio and SOPs) from 04.00PM onwards till 07.45PM, upon clearance of document verification. Stage II may continue on 26th April 2024 (starting at 09.00AM), depending on the number of eligible applicants. Applicants are advised to come prepared to be present in campus till end of 26th April 2024 to complete the Stage II.
6. SPA Vijayawada does not provide any boarding or lodging or travel arrangements.



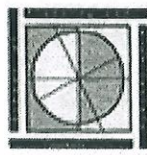
