



**NOTICE: Direct Admission to Post Graduate Programmes for the Academic Year 2024-25**

**School of Planning and Architecture, Vijayawada (SPAV)**, an Institute of National Importance established by the Ministry of Education (MoE) Government of India, announces the Direct Admissions for the Post Graduate Programmes under various specializations of Architecture, Planning and Design for the Academic Year 2024-25.

**Postgraduate Programmes at SPAV:**

Applications are invited for the Direct Admissions seats for the following programmes of Architecture and Planning:

Total Seats - 25 per PG programme (Two Years Full Time)

Wherein under CCMT Admissions – 13 Seats;

Wherein under Direct Admissions– 12 Seats

Wherein for M.Design, under Direct Admissions – All 25 seats

(wherein 50% of the seats of M.Design are to be self-financed)

*Note: Reservations for all the courses will be applicable for SC/ST/OBC-NCL/EWS/PwD as per rules of the Government of India.*

**Eligibility:**

- Sustainable Architecture:** Bachelor's Degree in Architecture from a recognized university.
- Landscape Architecture:** Bachelor's Degree in Architecture from a recognized university.
- Architectural Conservation:** Bachelor's Degree in Architecture from a recognized university.
- Master of Building Engineering and Management:** Bachelor's Degree in Architecture or B.E or B.Tech (Civil Engineering / Building & Construction Technology / Construction Engineering & Management / Construction Technology & Management) from a recognized university.
- Master of Urban Design:** Bachelor's Degree in Architecture from a recognized university.
- Master of Design:**
  - Bachelor's Degree in Architecture (05 year programme) from a recognized university or equivalent; OR
  - Bachelor's Degree in Engineering / Planning (04 year Programme) from a recognized University or equivalent, and with valid CEED score, AND with 1 year experience; OR
  - Bachelor's Degree in Fine Arts (03 year programme) from a recognized University or equivalent, and with valid CEED score, AND with 2 year experience; OR
  - Bachelor's Degree in Design (03 year programme) from a recognized University or equivalent, and with valid CEED score, AND with 2 year experience.

**B. Department of Planning**

- Master of Planning (Environmental Planning and Management)
- Master of Planning (Urban and Regional Planning)
- Master of Planning (Transport Planning)

**Eligibility:**

- Environmental Planning and Management:** Bachelor's Degree in Planning / Architecture OR B.E (Civil Engineering) or B.Tech Civil Engineering / Planning or Master's Degree in Geography / Economics / Sociology from a recognized university.
- Urban and Regional Planning:** Bachelor's Degree in Planning / Architecture OR B.E (Civil Engineering) or B.Tech Civil Engineering / Planning or Master's Degree in Geography / Economics / Sociology from a recognized university.
- Transport Planning:** Bachelor's Degree in Planning / Architecture or B.E OR B.Tech Civil Engineering / Planning or Master's Degree in Economics / Statistics / Operations Research from a recognized university.

**C. Marks/Grades Eligibility:**

For all the above PG programmes, the candidate must have secured a CGPA of 6.5 on a 10-point scale (or equivalent) or 60% marks in case of General/OBC-NCL/EWS candidates in qualifying degree, whereas in case of SC/ST/PH candidates a CGPA of 6.0 on a 10-Point scale (or equivalent) or 55% marks - in qualifying eligible degree will be applicable, or the applicable GoI norms adopted by institute from time to time.

**D. Admission Process:**

Admission shall be made through the following stages:

**Stage-I:** A Qualifying Entrance Examination will be conducted for the applicants. For more details about the Qualifying Entrance Examination, visit the SPAV website.

**Stage-II:** The candidates who have cleared the Qualifying Entrance Examination in Stage-I shall appear for the Stage-II. The final merit list shall be prepared based on the marks obtained in the Stage-II, which comprises of Interview and assessment of Statement of Purpose and Portfolio of academic / professional works, as per institute norms.

**(i) How to Apply:**

An applicant can apply for any number of PG programmes offered as given in 'A' and 'B'. However, applicant needs to submit separate application forms and supporting documents as separate sets/envelopes for each programme applied for. Fee should be paid separately for each PG programme applied for and the fee details to be enclosed in the respective



application forms separately in separate envelopes. Do not put multiple application sets in same envelope to post. The application form is available on SPAV Website <https://www.spav.ac.in> under Admissions section, which needs to be downloaded, duly filled, signed and sent with self-attested copies of required supporting documents. The duly filled in application form received through post, along with the required documents' self attested photocopies as mentioned in the application form should be sent to SPA Vijayawada by post/courier by the deadline.

**(ii) Students pursuing UG/PG degree:**

The candidates pursuing final year of the UG/PG Programme as per eligibility given in 'A' and 'B', can also apply and must submit the CGPA/Percentage of marks secured till the VI Semester (for 4 Years UG Programme) / IV Sem (for 3 Years UG Programme) / VIII Semester (for 5 Year UG Programme) / II Sem (for 2 year PG programme). Such a student is required to submit an undertaking/certificate issued by their institute, certifying that the applicant is 'appearing in final examination of final semester before June 2024'. Such candidates, if provisionally admitted, are required to submit final year mark sheets and provisional degree certificate, during the physical reporting at SPA Vijayawada. Candidates who have completed the eligible UG/PG programmes in previous years are required to produce provisional degree certificates, in case the original degrees are not issued.

**(iii) Deadline and Address to Post:**

Envelopes to be super-scribed / have written the text on top "**Application for Admission to (write the name of programme applied for)**" and also have the full candidate's name with full postal address on the envelope as 'sender'. Envelopes to reach the institute through post/ courier on or before **05<sup>th</sup> April 2024 05.00 PM**. Applications received after the last date will not be considered, irrespective of postal or any other delays. The short-listed candidates shall be notified on the School's website and must produce the original documents and certificates & a set of self-attested photocopies, photos and portfolio of academic / professional works etc., at the time of Qualifying Entrance Examination / Interview.

**E. General Instructions:**

**(i) Application Fee for PG Programmes:**

Application fee (non-refundable) for PG programmes per course is **Rs.2,000/-** (Rupees Two thousand only) for General/OBC-NCL/EWS categories and **Rs.1,000/-** (Rupees One thousand only) for SC/ST/PwD categories and can be paid through online only. If an applicant is applying to multiple PG Programmes, he/she should pay the fees separately for each application & enclose the proof with each application.

**(ii) Scholarships**

Candidates applying for 'Direct Admission for PG' are not ordinarily eligible for scholarships and are required to be prepared for financing their studies as per Fee structure of the Institute. Institute reserves the right to decide on scholarships, if any, for those admitted through Direct Admissions.

**(iii) Guidelines for Sponsored Category:**

The candidates who are employees of a Public Sector Undertaking, a Government Department, a Research & Development organization/lab, a recognized Planning / Architectural Office of repute, can apply under the Sponsored category as per norms of the Academic Ordinances. Such a candidate must have been in employment with the sponsoring organization for at least two years at the time of admission and should submit - (a) letter confirming sponsorship, period of employment, and confirming study leave (or extraordinary leave) from the organization for entire duration of studies at SPA Vijayawada, and (b) a No Objection Certificate for entire period of studies at SPAV.

**(iv) Submission:**

Application forms which are incomplete, not signed, or does not have enclosed the required self-attested copies of documents as indicated in this notification or the application form, is liable to be summarily rejected. On qualifying Stage I the applicant needs to appear for Stage II. The School reserves the right to reject/cancel any application without assigning any reasons.
