50% of the total seats shall be regular seats following the 1st year fee structure for A.Y. 2024-25 of the existing PG programs at SPA Vijayawada. These seats will be allotted as per merit of the selection process.

Remaining 50% seats shall be self-financed with a fee structure having an additional 80% fee for all fee subheads of tuition fee for candidates of all categories, in comparison/accordance with the regular fee structure. These seats will be allotted after filling up of the 'regular seats' (Table 4), as per merit of the selection process.

B. Qualifying Entrance Examination

Applicants screened and found to be eligible for the admission process would be notified on Institute website as per date schedule given in the announcement. Such candidates would have to appear for qualifying entrance exam to be held on dates as mentioned in the notification. It is advised to make prior arrangements, for coming to SPA Vijayawada campus on the dates of qualifying entrance exams (stage I) and thereafter, the interview (stage II).

There shall be 'one' qualifying entrance exam for all M.Arch and M.Urban Design aspirants; 'one' qualifying entrance exam for all MBEM aspirants; 'one' qualifying entrance exam for all M.Design aspirants; & 'one' qualifying entrance exam for all M.Plan aspirants. Therefore, for example, if an

applicant has applied to multiple Programmes related to M.Architecture, M.Urban Design, MBEM, M.Design and M.Planning, he/she would be required to appear for 04 exams in total on the same day. Also for example, if an applicant has applied to multiple Programmes related to M.Planning only, he/she would be required to appear for 01 exams in total on the same day.

C. Declaration of Provisional Selection List:

Provisional Selection List will be declared after completion of Stage I and II, within few days on the institute website on dates as mentioned in the notification. Candidates would have to pay the full requisite Fees online in order to confirm their seats within the deadline along with a seat confirmation declaration. After deadline, if a candidate who was offered a seat in the first merit list and has not paid and confirmed the seats within deadline, will be losing the seat and the vacant seats will be offered to waitlisted candidates as second merit list. Therefore, candidates are advised to make prior financial arrangements to complete fee payment within the deadlines in online mode to be able to secure seats.
