

Agenda	The C & AG vide No.DGA(C)/CEA-01/LAR/2021-22 AE No.29 dated 14.03.2022 vide para No.V (I) Inadmissible Payments mentioned that: In rent free accommodation, rent of the flat is exempted from recovery. However, maintenance charges have to be borne by the individual.
	The Institutes vide letter dt.21.03.2022 replied that the payments were made as per rent agreement.
	C&AG vide para 3 of their above referred letter said that the reply is not acceptable as the electricity and flat maintenance charges are to be borne by the tenant. Besides, the defective clause in the rent agreement resulted in inadmissible payment.
V C(a	C&AG has attached detailed calculation sheet as along with their Report for an amount of Rs.1,58,250/- towards Maintenance Charges and Rs.1,56,707/- towards Electricity Charges.
	The reporting of pending audit paras was placed in the 21 st F.C vide Agenda item no. 21.13 as per the instructions of MoE.
	The F.C. resolved to inform NIT, Hamirpur for recovery of the amount i.r.o Prof.Minakshi Jain for inadmissible payments from Institute Fund as per the observations of C&AG.

Decision	After detailed deliberation, FC recommended to get the observation of the C&AG dropped by providing additional details with regard to admissibility.
23.23	Registration of SPA Vijayawada under Section of 8 of Company Act
Agenda	In line with the School of Planning & Architecture, Delhi, other IITs, NITs, CEPT and other premier institutions where Architecture& Planning is taught, School of Planning & Architecture, Vijayawada wants to initiate action regarding registration under Section 8 of Company's Act. This is considered to be a pre-requisite for being recognized as A Centre of Excellence as well in architecture, Planning, Design or any related domain. This would also help in setting up of start-ups and other related innovation activities, other than promoting Institution Research & Consultancy Activities further.
	The needful steps for the same have been identified as preparing 'Articles of Association', and 'Memorandum of Association' in consultation with Chartered Accountant of SPAV and SPA V engaged Legal experts. The Board of Directors and Team Members would have to be finalized in due course.
	Further, the Vision, Mission, Aim and Objectives for the same would be drafted, alongside Institute Intellectual Property Rights Policy Document, Innovation &



	Start Up Policy and Incubation Centre Policy. The FC may Consider the proposal.
Discussion	The matter with regard to registration of SPAV under Section 8 of Company Act was discussed in details. The details of the Vision, Mission, Aim and Objectives for the same should be drafted, alongside Institute Intellectual Property Rights Policy Document, Innovation & Start Up Policy and Incubation Centre Policy and once again place it before the FC for consideration.
Decision	FC considered and recommended to adopt the procedure followed by SPA Delhi in principle.
