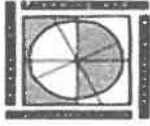

The CPIO has denied the information sought vide reply dated 18.01.2024 without any application of his own mind. The CPIO has mentioned that the 'disclosure of the candidates would harm the competitive positions of the candidates applied' and I could not find any meaning for the sentence he has written. It is not understood as to what are competitive positions and how there is a harm. The CPIO has given an irrelevant case law i.e CBSE Vrs Aditya Bandopadhyay and others, where the case is about re-evaluation of the answer book or supplementary answer book. Two more other cases are also referred by the CPIO where the information sought is about name, designation and address of the selection committee and interview board, which is not my case. The CPIO has totally failed to understand the information sought and at least he could have sought the guidance from the experienced Registrar of the school. The CPIO could have hidden the address or any personal information of the applicants if any and provided the information, but opted to dilute the RTI act. As such the names selected/shortlisted candidates for the written test are already in public in SPAV website. This information definitely attracts public interest as the process of recruitment was postponed at a very close date i.e just one day before the written test date where all the applicants have made all travel arrangements, spent lot of money for travel, accommodation etc but without any concern/regret the authorities have post poned the exam and the administrative reasons should come out in the public interest. MY PRAYER/PLEA IN THIS FIRST APPEAL: 1. Instruct the CPIO, in writing, to give complete information as requested in my above mentioned RTI Application 2. Issue a written warning to the CPIO, under the present Rules and Regulations of Service, instructing him/her that he should adhere to the RTI Act 2005 to provide information as well as respect the RTI Act in its letter and spirit. 3. Inform the concerned CPIO that the appellant will move a Second Appeal before the CIC under Section 19(3) and will demand imposition of Penalty under Section 20 of the RTI Act, at the rate of Rs. 250.00 for every day of delay (subject to a maximum of Rs. 25,000.00) from the date the information was due 20.01.2024 till the date the information is actually given to me. 4.
