Response to RTI SPAVW/R/E/24/00050, dt. 17/09/2024

1. As per the Office Order SPAV/Dir/Camp Office/ Duties/2021/31-40, issued on 05th May 2021, the "Faculty-In-Charge, Legal Matters is requested to look into the legal matters along with the Legal Advisor of SPAV and dispose of the matters on urgent basis from time to time". In this Office Order, dated 05.05.2021, Dr. Uma Shankar Basina, Associate Professor of Architecture, was nominated as Faculty-In-Charge, Legal Matters. The Legal Advisor/ Standing Counsel of School of Planning and Architecture Vijayawada (SPAV), at the time of filing of WP 34687/2022 is Smt. A.V.S Laxmi, on monthly Retainer Fee, to represent School of Planning and Architecture Vijayawada (SPAV) on all legal matters in any legal court.

Also, it is submitted that, since the First Respondent in this case, i.e. WP 34687 of 2022, is "GOVERNMENT OF INDIA", requiring reference to the D.O No. J-18/50/2021-Judicial, dated 09th December 2021, issued by the Office of the Secretary, Higher Education, Government of India, observing that "some of the autonomous bodies functioning under the respective Ministries/Departments have been availing services of their own panel counsel or private counsels, in litigations wherein Union of India is also a party. As such, any adverse decision of the courts impacts the policy framework of the Government of India. In view of the above, all the Ministries/Departments are advised to issue instructions to the autonomous bodies under their administrative control that the cases wherein Union of India is also a party along with an autonomous body, the same should be defended on behalf of both, the autonomous body as well as Union of India before any Court or Tribunal by the panel counsel engaged by the Department of Legal Affairs only". The same may please be considered.

Referring to the case details from the Website of e-High-Court of Andhra Pradesh, the said Writ-Petition WP no. 34687/2022 was filed and registered on 21.10.2022, under the classification "Stay Petition". In response to this, Learned Counsel Shri N. Appa Rao, on behalf of Smt. AVS Laxmi, appeared for the case in the Hon'ble High-Court of Andhra Pradesh, on 27.11.2023, representing Respondents 2 to 5, and sought additional time to file the Counter-Affidavit, and three weeks of time was granted for

filing the Counter-Affidavit; wherein Respondent 2: School of Planning and Architecture Vijayawada; Respondent 3: The Director, SPAV; Respondent 4: Ms. Meenakshi Jain; Respondent 5: The Registrar, SPAV. The Hon'ble Judge directed to list the matter on 23.12.2023, and also directed the Registry to print the name of Deputy Solicitor General for the Respondent No. 1 in the Cause List. Further, on 23.12.2023, Shri N. Appa Rao, appeared in the Hon'ble High Court of Andhra Pradesh, on behalf of Smt. AVS Laxmi, and sought further time to file the Counter-Affidavit and three weeks time was granted. The matter was directed to be listed on 06.02.2024, on which date, the case number could not be reached for hearing.

Meanwhile, notification for General Elections 2024 (Assembly & Parliament) was announced in March 2024, making Election Code in effect. The General Elections process concluded in June 2024, resulting in subsequent change in the Government of Andhra Pradesh State, and appointment of key legal positions. Therefore, the filing of Counter Affidavit is taking time.

2. The Counter Affidavit in the case WP No. 34687 of 2022, is yet to be filed, till date.

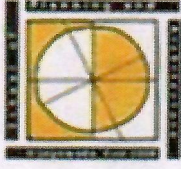

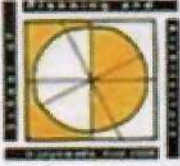

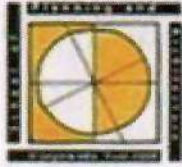
